26.01 Membership Fees

- a. Competing Team
 - 1. Adult Team 55.00
 - 2. Youth Team 20.00
 - 3. When all JO rostered players are individually registered / \$10.00 per player.
- b. Discount for Competing Teams */1
 - Affiliation through a league 21.00
(All teams in the league must be registered, together)
- c. Umpire
 - 1. Adult 60.00
 - 2. Adult (19 – 24) 30.00
 - 3. Youth(18 & under) 30.00
(January 1st of current to determine year age)

26.02 Tournament Entry Fees - (Maximum Allowed)

- a. State 300.00
- b. Junior Olympic 450.00
- c. Regional per ASA Code

26.03 Tournament Assessment Fees

- All tournaments (per team) 30.00

26.04 Tournament Sanction Fees

- Invitational Tournament's (per team) 10.00

26.10 Tournament Umpire Compensation

- a. State, Qualifier, Regional Tournaments held with the WASA Association.
 - 1. Game Fee
 - a. Adult Fast Pitch 37.00
 - b. JO Fast Pitch Class A & B 37.00
 - c. JO Fast Pitch Class C 37.00
 - d. Modified Pitch 33.00
 - e. Slow Pitch 25.00
- b. ASA National Tournament per ASA Code.

26.11 Tournament UIC Compensation (Wisconsin State Tournaments Only)

National Qualifiers, Northern Nationals and all ASA Nationals are the responsibility of the host tournament site.

Compensation to the tournament UIC will be split into a base fee + \$1 per game assigning fee. Site UICs will only be paid a base fee on days additional site is required unless tournament UIC requires assistance for the duration of the tournament. **Paid for by the Tournament Director.**

- a. Tournament UIC
 - 1. 4 day tournament \$450 + Game Assigning Fee
 - 2. 3 day tournament \$350 + Game Assigning Fee
 - 3. 2 day tournament \$250 + Game Assigning Fee
 - 4. 1 day tournament \$150 + Game Assigning Fee
 - 5. Additional days \$100 per day + Game Assigning Fee
- b. Site UIC
 - 1. 4 day tournament \$400
 - 2. 3 day tournament \$300
 - 3. 2 day tournament \$200
 - 4. 1 day tournament \$100
 - 5. Additional days \$100 per day

26.12 Tournament Umpire Lodging

1. WASA State Tournaments
 - a. Housing will be provided by the tournament host/sponsor if required.
 - b. Housing will be for 2 umpires per room.
 - c. The tournament director will be responsible for all rooms UIC's and umpires that live outside 50 miles from the main complex. If an umpire requests a private room he/she must pay half for the room. (State Commissioner has the authority to under certain conditions approve a private room)
 - d. Equivalent arrangements can be submitted for direct payment of rooms.

26.13 WASA Tournament Representative

- a. Administrative Fee
 1. The WASA Tournament Representative appointed by the WASA Commissioner will be reimbursed for travel expenses as listed.
 - a. Mileage to and from the tournament at the WASA rate.
 - b. Hotel room if approved by the WASA Commissioner.
 - c. Meal allowance as approved by the WASA Commissioner.
 - d. One full day at tournament site \$100, two full days at tournament site \$200 and \$250 if tournament is more than 2 full days as approved by the WASA Commissioner.
(The WASA will reimburse the fee for assigned WASA Tournament Representatives.) WASA Representative will only receive reimbursement as approved by the WASA Commissioner and if all applicable tournament forms have been turned into the WASA office at the conclusion of the tournament. No representative will receive additional reimbursement due to multiple positions with the WASA.

*1 Requires 100% ASA registration of the league or association.

*2 Includes accident and liability insurance.

*3 Representatives will be assigned by the State Commissioner.
